This is a final response to your Privacy Act request which was received in the Transportation Security Administration's (TSA) Freedom of Information Act and Privacy Act Division on August 25, 2005. You requested the following information:

"Records about myself held by your agency obtained in connection with any and every aspect of the Secure Flight Test Phase."

Your request was processed under the Privacy Act 5 U.S.C. § 552a and the Freedom of Information Act, 5 U.S.C. § 552. We previously responded to your request on September 9, 2005 and requested that you provide us with additional information to assist us with our search. We received a response from you on September 26, 2005, which provided us with the requested information.
